## 1) RULES IN RESPECT OF FEES PAYABLE

- Ruhamah College retains the right to alter any fees or other stipulations regarding fees payable.
- By signing and submitting the registration form, students accept responsibility for the payments and bind themselves to
  abide strictly by the regulations regarding the payment of all fees. In the case of minors, parents accept co-responsibility.

### 2) COLLEGE FEES FOR ALL FULL TIME AND MODULAR STUDENTS ARE PAYABLE AS FOLLOWS:

- Application Fee: R350.00 must accompany the form. (Once off Payment))
- Enrolment Fee of R1,400.00 payable on receipt of your letter of acceptance and student number. (Once off Payment)
- Module payments are payable upfront before commencement of studies.
- Payments can be made per trimester upfront. (You can only take two modules per trimester)

#### 3) CANCELLATION OF STUDIES / MODULES

- All cancelations must be done in writing, addressed to the Dean stating your reasons for cancellation.
- Confirmation of the acceptance of cancellation from Ruhamah will be issued to the applicant in writing.

# 4) STUDENTS MUST ADHERE TO THE PAYMENT DATES AS SET OUT UNDER THE TERMS AND CONDITIONS

- Students, who do not adhere to the payment dates, will not be registered, allowed to attend classes, receive study material, or receive online access.
- All fees paid are not refundable. Fees will be kept in credit for 12 months ONLY from date of registration.

# 5) IN RESPECT OF STUDENTS NOT FULFILLING THEIR FINANCIAL OBLIGATIONS ON TIME AS PRESCRIBED, RUHAMAH RETAINS THE FOLLOWING RIGHTS

- Students will be excluded from all class attendance and the online portal for submission of assignments and examinations.
- Student's examination and assignment result will be withheld.
- Students will not be allowed to register when outstanding fees have not been paid in full.
